1) Invitation for E- Auction

1.1) Brief Introduction

- a) Samaj Mandir is plot under reference (u/r.), part of Vartak Nagar Mhada Colony layout situated in Panchpakhadi, Majiwade, Sector IV, Thane. This plot is designated for cultural and social activities of local Mhada beneficiary.
- b) The existing Samaj Mandir structure/facility was demolished by the local authority, declaring the structure as dilapidated. Presently, the plot is partially encroached and the plot admeasures 1783.51 sq.mts. including the said encroachment and the permissible FSI for this plot is as under:

- c) Presently, most of the buildings in Vartak Nagar Mhada Colony layout are redeveloped or under redevelopment. Thus, rise in existing population and rise in local demand for social cultural activities.
- d) Mhada has decided to dispose this land parcel to public charitable trust or Societies registered under Societies Registration Act 1860 (XXI of 1860). The successful bidder shall be granted this land parcel to create a facility which shall meet the local demand of social and cultural activities as well as shall accommodate the programmes promoted by Mhada.

1.2) Purpose of Expression of Interest:

- b) Design, build, operate and maintain Samaj Mandir facility with the help of Executor for 30 Years (2 Times renewable lease)
- c) Provide state of art structure to facilitate the social and cultural activities of local Mhada beneficiaries.
- d) Provide free of cost 10 Mhada programmes per year. In case of additional Mhada programmes the facility provided shall be charged at no loss no profit basis.
