2. The payment for Tender Form Fee and Earnest Money Deposit (EMD) must be made online.
3. Bids will be Opened on 12/02/2026, 17:40 p. m. onwards at office of Executive Engineer City Division, M .H & A. D. Board, Griha-nirman Bhavan Kalanagar, Bandra(E), Mumbai- 400051, on web site **<https://mahatenders.gov.in>**
4. e-Tenderer Should submit original documents (those were uploaded during bid preparation) for verification at the time of Technical Bid opening.
5. Bidder should submit information and scanned copies in **.rar** format in Technical Envelope as mentioned in Technical Offer.
6. Time and date of Opening of Commercial Bid will be informed to the qualified bidder.
7. The contractor / Agency should have specialized experience of carrying out repairing i.e., replacement of tiles, flooring, replacement of door shutters, door frames, sliding window, painting, plumbing work, water proofing.

The certificate issued by the Executive Engineer of the concern department, or the bill of quantities certified by the competent authority or certificate issued by Architect in case of private work will have to be uploaded during bid submission reflecting any two above techniques clearly.

8. e-Tenderer should have valid class II/ III Digital Signature certificate (DSC) Obtained from any certifying authority.
9. Pre-Qualification /Eligibility Criteria:

- a. Bidders Annual turnover in last five years maximum 75% of the estimated value of the work.
- b. Bidder having completed at least similar work having,
 - 1. At least 3 Nos. similar works completed with 40% of estimated tender value of the work.i.e Specially water Supply work/U.G pipeline work.
 - 2. At least 2 Nos. similar work completed with 50% of estimated tender value of the work. . i.e Specially water Supply work/U.G pipeline work.
 - 3. At least 1 No. similar work completed with 80% of estimated tender value of the work. . i.e Specially water Supply work/U.G pipeline work.

10. The Executive Engineer (City) / Mumbai Board, Grihanirman Bhavan Kalanagar, Bandra(E), Mumbai- 400 051 reserves the right to accept or reject any or all tenders without assigning any reason.

11. **Additional Performance Security** – (Only in case of tenders with premium % below Estimated cost put to tender)

- a) If offer quoted is upto 10 % below Estimated Cost, then Agency shall submit **Bank Guarantee /Demand Draft/FDR** of 1 % of Estimated cost put to tender , towards **Additional performance security** other than Security deposit mentioned in Tender notice. The **Bank Guarantee Demand Draft/FDR** in original should be submitted in sealed envelope alongwith attested copy of solvency and Bank conformation letter.
- b) If offer quoted is more less than 10 % below Estimated Cost, then Agency shall submit Demand Draft of amount; which shall be worked out as "(Quoted offer in % - 10 %) + 1 %" of Estimated cost put to tender. For example, if, offer is 14 % below , then performance Security to be paid will be $(14 \% - 10 \%) + 1 \% = 5\%$ i.e. Total 5 % of Estimated cost.
- c) If offer quoted is more less than 15 % below Estimated Cost, then Agency shall submit Demand Draft FDR /BG of amount, which shall be worked out as.

For example, if, offer is 19 % below, then performance Security to be paid will be.

 - i) $10\% \text{ less- } 1\% = 9\%$
 - ii) $10-15\% - (15-10) = 5\%$
 - iii) $19-15= 4 \times 2 = 8\%$
 - iv) $p. s= 1+5+8= 14\% \text{ at estimated cost.}$

d) Demand Draft/FDR of Additional performance security shall be issued in favour of Chief Accounts Officer Mumbai Board, MHADA. Demand draft shall be issued by Nationalised Bank or Scheduled Bank, within Maharashtra State.

e) The maturity date of Demand Draft/FDR shall be at least 3 months from date of submission of E-tender.

f) The MICR and IFSC code shall be mentioned on Demand draft.

g) Bank guarantee shall be issued either by nationalised/schedule bank.


