The Hon'ble Chief Secretary before concluding the meeting pointed out that a proper system shall be established to see and monitor that the houses constructed under these schemes are allotted to the eligible families and at a decided price at the time of approval. It was assured by the Mission Director such system will be devised and will be applicable throughout the State where the scheme is being implemented.

The ACS, Environment made a point that the construction of tenement shall not be undertaken unless the building permission is obtained and due environment clearance is at place in all the schemes. Further ACS added that where environmental clearance is not required in such projects the MHADA Nodal Agency shall ensure that the environment infrastructure such as sewage line connectivity, STPs and solid waste management comply with the existing rules of CPCB/ MPCB for all projects.

The meeting was ended with vote of thanks.
