1) Marking of beneficiaries on DP sheet is not done. 2) Plot areas of some of the beneficiaries are not mentioned in beneficiary list. 3) ULB to ensure eligibility of beneficiaries as per guidelines, land ownership and development as per norms of ULB.

C. SLSMC Appraisal:-

The Chairman, SLSMC directed that for BLC projects beneficiary attachment should be completed.

It is recommended to submit the DPR to CSMC and ULBs to comply with above observations.
