8. Tenderer should have valid class II/ III Digital Signature certificate (DSC) obtained from any certifying authority.
9. The Executive Engineer (East) / M.S.I.B, MHADA, Bandra (East), Mumbai – 400 051 reserves the right to accept or reject any or all tenders without assigning any reason.
