

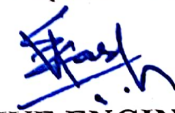

- Blank tender form shall be issued only on production of original or photo set copies (duly attested) of latest valid registration, PAN Card, GST certificate etc.
- The tender amount is excluding GST. GST shall be paid by MHADA separately.
- Joint-ventures are not acceptable for the work mentioned above.
- Copy of Affidavit regarding completeness, correctness and truthfulness of documents submitted on Rs. 500/- Stamp Paper.
- 2% of the amount put to tender should be remitted towards initial Security Deposit at the time of agreement.
- All Contractors/Bidders (including Contractors registered with MHADA & PWD) shall submit Solvency certificate of amount of 20% of Estimated cost should be issued by nationalized bank/ scheduled bank put to tender in Technical bid.
