- 3 The Contractors who are not registered in M.H.A.D.A. should produce certified copy affidavit duly notarized that they are not black listed in Government or Semi. Government organisation at the time or submission of tender forms.
- 4 Copy of Affidavit regarding completeness, correctness and truthfulness of documents submitted on Rs. 500/- Stamp paper before Executive Magistrate/ Notary.
- 5 Earnest money. deposit shall be paid in the form of short terms deposit receipt for the period of the one year issued by the nationalised/ schedule bank and endorsed in the name of Chief Accounts Officer , M.B.R. & R. Board, Mumbai.
- 6 The Blank Tender will be issued by the Executive Engineer G/N Divn., M. B. R. & R. Board, Sonawala Building, Gr. Floor, 8, S. A. Palav Marg, Shidewadi, Dadar (E), Mumbai- 400 014.
